## **Programme Overview**

The Environmental Humanities offer leading-edge interdisciplinary responses to today's complex and urgent environmental challenges, bringing knowledge and insights from the arts, humanities and social science into critical conversation with natural science understandings. Drawing on world-class expertise from across the Schools of Writing, Publishing and the Humanities, Sciences, and Education, Bath Spa's MA in Environmental Humanities addresses specific problems such as biodiversity loss and climate change, but also broader ideas about human relationships with place, technology and the more-than-human world. This programme is an opportunity to acquire new research skills, as you discover the challenges and rewards of integrating highly varied methodologies, resulting in more holistic forms of knowledge and understanding. Core modules taught by specialists offer intensive introductions to new disciplinary perspectives, while maintaining a critical focus on key ideas such as the proposition that Earth has now entered a new geological era, the Anthropocene, in which human activities are altering the planet in ways that will leave their mark for millennia.

The programme is designed for flexibility, offering a palette of elective modules that will also enable you both to learn new approaches and to consolidate your expertise in a particular discipline such as history, geography, anthropology, literary studies, philosophy, ethics and religion, environmental studies, or conservation. A significant research project or creative practice component makes this a personally as well as intellectually transformative course which is very much yours to mould to your own needs through module and dissertation choices.

Multidisciplinary and interdisciplinary research methods training will enable you to continue on to doctoral studies in either the humanities or social sciences, and your major project can take the form of either an academic dissertation or a creative work. However you shape it, you can be confident that given the growing demand for graduates with cross-disciplinary skills and understanding, your MA in Environmental Humanities will provide a solid basis from which to contribute to the 'green' society and economy of the 21st century.

## **Programme Aims**

The overall aim of this programme is to enable students to bring knowledge and insights from the arts, humanities and social sciences into critical conversation with the natural sciences in order to better understand and address today's complex environmental problems in their wider cultural context. In this programme you will study:

- 1 How social and cultural factors shape human relations with other living beings and more-than-human environments, and vice versa;
- 2 Key concepts that have been developed within the Environmental Humanities to analyse such interrelationships;
- 3 Ecologically oriented approaches across a range of disciplines in the humanities and social sciences:
- 4 Ways of bringing together different kinds of knowledge (e.g. ecological, literary, anthropological, philosophical, geographical, but also traditional and indigenous) in order to address today's complex socio-environmental problems.

Students will be supported in their development towards summative assessment by appropriate formative exercises.

<u>Please note</u>: if you choose an optional module from outside this programme, you may be required to undertake a summative assessment task that does not appear in the assessment grid here in order to pass that module.

### Work experience and placement opportunities

Whilst this course does not currently include a formal workplace experience module, it may be possible for students to connect with environmental organisations such as the National Trust, RSPB, Avon Wildlife Trusts, or social enterprises, such as EcoWild, in relation to their dissertation/creative project. Staff delivering the programme will also make students aware of their own relevant external links and networks, and draw on these as appropriate.

Career opportunities for graduates with an MA in Environmental Humanities include working in socio-environmental research and education;

local, national and international conservation organisations; environmental film, TV, and other media; environmental journalism, art and creative writing; eco-tourism; private companies with a strong sustainability agenda; and local, national and international governmental agencies concerned with conservation, climate change, and sustainable development.
